2. Executive summary

There were some significant changes in the SUD quarterly measures, as explained below. The District attributes several increases to a rebound in utilization following the COVID-19 omicron surge in the previous quarter.

While the HIT metrics generally continued to increase, there was a decrease in the number of users who performed a patient care snapshot due to a configuration change, as explained below. The District also notes the launch of a new tool within the health information exchange to enable patients to consent to share their SUD treatment data.

Finally, there was a significant increase in critical incidents. The District attributes this change to natural variation.
