Dear Ms. Callahan:

I am writing to inform you that the Centers for Medicare & Medicaid Services (CMS) has approved your title XXI Children's Health Insurance Program (CHIP) state plan amendment (SPA) number 16, submitted on June 27, 2014, with subsequent clarifying information submitted on October 14, 2014. This SPA permits Massachusetts to implement one additional Health Services Initiative (HSI) program: Services for Homeless Youth. The effective date of this SPA is July 1, 2013.

This SPA authorizes Massachusetts to use title XXI funds through the option at section 2105(a)(1)(D)(ii) of the Social Security Act to pay for an HSI. Using remaining funds available that do not exceed the 10 percent limit on expenditures that include administration of the plan, the state may fund activities that protect public health, protect the health of individuals, improve or promote the state's capacity to deliver public health services, or strengthen the human or material resources necessary to accomplish public health goals related to children. The state shall ensure that it prioritizes complete funding necessary to ensure efficient and effectiveadministration of coverage requirements ofthe CHIP plan established under section 2105(a)(1)(D)(v) of the Act, within the state's 10 percent limit. If such funds become less than sufficient, the state agrees to redirect title XXI funds from the support of this HSI to the administration of the CHIP program. The state shall report annually to CMS the expenditures funded by the HSI on a federal fiscal year basis.



Section 3: Methods of Delivery and Utilization Control (Section 2102(a)(4))

• Services for Homeless Youth

Through Services for Homeless Youth, the Department of Early Education and Care (EEC) contracts with licensed organizations to provide a stable, nurturing environment that meets the individual, developmental, behavioral and emotional needs of homeless youth. Each family is assessed for their unique issues and needs and the provider develops a "Family Service Plan" to address the needs. Each child is assessed for developmental concerns and where developmental delays are identified, appropriate referrals are made. Parents are provided access to parenting programs, a variety of community resources (e.g., WIC), nutritional guidance, information on building positive parent-child interactions, and skills to help identify the best quality child care for their children. Based on the "Family Service Plan", when therapeutic supports are needed (medical, psychological, etc.), providers assist parents in accessing needed services.
