Information about the ECM program, including the request for applications (RFA) and questions and answers about the RFA have been posted at Ohio Medicaid's web site. The web site will continue to be updated as relevant information becomes available. Finally, the state's Medical Care Advisory Committee (MCAC) has also served as a forum for discussion of the ECM program. As the ECM program enters its implementation phase, Ohio Medicaid will continue to seek input through public meetings and the MCAC.
