Dear Ms. Mann:

Iowa is in receipt of the Centers for Medicare & Medicaid Services (CMS) approval to amend the Special Terms and Conditions (STCs) and the waiver authorities of Iowa's 1115 demonstrations entitled, "Iowa Wellness Plan" (Project Number 11-W00289/5) and "Iowa Marketplace Choice Plan: (Project Number 11-W00288/5). Given the clarifications below, this serves as Iowa's formal acceptance of the revised STC's dated December 31, 2014.

Iowa would like to clarify that although the amended STCs give Iowa the authority to continue to forego non-emergency medical transportation (NEMT) services to all members of the Iowa Health and Wellness plan, Iowa has been and will continue to provide NEMT services to members who have a medically exempt determination and who are under the age of 21.

Additionally, Iowa requests that CMS make the technical corrections described in the attachment entitled, "Technical Corrections Needed" in the amended STC's.

Finally, in your letter that we received on December 30, 2014, not only does CMS give amendment approval but you also acknowledge that, due to the withdraw of one of the Qualified Health Plans (QHP) in the Marketplace Choice Plan (MPC), beginning January 1, 2015, Iowa will allow members to choose to receive coverage from the remaining QHP in the MPC or the Wellness plan. Iowa plans to submit an amendment request to effectuate this change.

We appreciate the continued partnership we have had with CMS through the first year of implementation of the Iowa Health and Wellness plan. We look forward to continuing this partnership as we move into 2015.
