## Dear Ms. Janu:

The Indiana Family and Social Services Administration (FSSA) Office of Medicaid Policy and Planning (OMPP) is pleased to learn that the Centers for Medicare & Medicaid Services (CMS) has approved the State's request to amend the Healthy Indiana Plan §1115 waiver seeking federal authority to reimburse for acute inpatient stays in institutions for mental disease (IMD) for individuals diagnosed with a serious mental illness (SMI).

FSSA – OMPP understands that technical corrections to the Special Terms and Conditions (STCs) may be requested following the amendment approval. Therefore, FSSA – OMPP would like to take the opportunity in this acceptance letter to request the following technical correction to the STCs accompanying your correspondence dated December 20, 2019:

- It appears the reference to withdrawal management services should be removed, as that treatment modality applies to substance use disorder stays only. The reference should read: "Expenditures for Medicaid state plan services furnished to eligible individuals who are primarily receiving short-term treatment and withdrawal management services for a serious mental illness (SMI) in facilities that meet the definition of an IMD."
- In accordance with ongoing discussions with CMS, FSSA OMPP requests an update to the budget neutrality table in STC XV.3 as follows:
