| | Presumptive Eligible | 17,355 | Presumptive Eligible for HIP (aid category MAHA). Not included in enrollment details. |
| | Native American (opt-out) | 26 | Members who were confirmed Native American, but opted out of HIP (aid category MANA). |
| | Emergency Services | 18,615 | Members who were confirmed eligible by eligibility determination, but were flagged for Emergency Services only (aid category MAER). |
| | Total Enrolled & Eligible | 402,451 | All members enrolled at HP, regardless of status, to include all open members, conditional members, and those with presumptive eligibility. |
