Introduction:

The Healthy Indiana Plan (HIP) was designed for those that do not have access to health insurance and that are not eligible for other Indiana Medicaid programs. Through a December 14, 2007 letter from Kerry Weems, Acting CMS Administrator, the State of Indiana Family and Social Services Administration (FSSA) Secretary was informed HIP was approved as the Indiana Section 1115 Medicaid Demonstration Project (11-W-00237/5) for a five year period – January 1, 2008 through December 31, 2012 – in accordance with section 1115(a) of the Social Security Act. Indiana has received CMS approval to extend the HIP program through December 31, 2014.

The goal of this approved demonstration is to:

- Provide high deductible health insurance plan
- Provide Personal Wellness & Responsibility (POWER) Account (like a HSA)
- Provide health insurance to uninsured custodial parents (caretakers) of Medicaid & SCHIP children with family incomes 22% of federal poverty level (FPL) up to 100% of FPL
- Provide health insurance to non-custodial parents and uninsured childless adults (non-caretakers) with family income up to 100% of FPL.

This demonstration is the first of its kind in the United States and has a unique empowerment of enrollees (members) to be cost and value conscious while promoting personal responsibility, which includes:

- Specified monthly POWER account contribution ranging from 2% 5% of gross income.
- Twelve month lock out from program for members that do not make payments within 60 days.
- Incentivizes yearly preventative services at no cost and are funded outside the POWER Account.
- Total remaining balance in the POWER account rolls over when preventative services are obtained.

Provide a summary of the types of complaints or successes consumers identified about the program in the current quarter.

Some issues that have been present include the transition of pregnant women in and out of HIP. In addition, the question of how to cover claims for a woman enrolled in HIP who miscarries prior to transitioning to Hoosier Healthwise is also continuing to be researched.

Include any trends discovered, the resolution of complaints, and any actions taken or to be taken to prevent other occurrences.

An ongoing issue exists with conditional members that do not close automatically for non-payment. The issue surrounding this is because the individual typically has a previous debt that was never paid. The problem has identified as not being able to see if a member has debt at the time of application processing leading to different information being seen at different locations. The resolution for this issue is to manually close cases after they stay in conditional status for more than 90 days so that the individual may re-enroll at that time.

Lastly, the transition from a 209(b) to 1634 state led to some issues with the auto-closures that were supposed to

occur once the prior program ended. To resolve the issue the State initiated a process to have all alerts sent directly to the State so that any closures that needed to occur could be done so manually. This process has been effective in solving the issue and the lack of auto-closure on these cases is no longer an issue.

MDwise

MDwise has integrated the promotion and education of the Healthy Indiana Plan since the plan originally started in 2007. MDwise achieves successful promotion of its Healthy Indiana Plan by conducting outreach, education, and marketing, to its Healthy Indiana Plan members and providers. MDwise strives to educate its members on the importance of receiving preventive care, knowing their medical home, and how to reach MDwise for additional resources.

MDwise provides its providers with all the resources and information needed to deliver low cost, high quality care to its members. Below are some initiatives MDwise established and completed to provide quality health care to its Healthy Indiana Plan members in Q2 2014.

One of the strengths of the MDwise outreach team is their opportunity to interact directly with MDwise members and community members in communities throughout the state. While, MDwise outreach incorporates HIP education into all their outreach efforts, there are events and presentations when the outreach team has an opportunity to interact with MDwise HIP members across the state of Indiana. The outreach team assists in confirming member's HIP plan, explanation of HIP benefits, the MDwise Rewards Program, creation of the myMDwise portal benefits of the Power Account, how to maintain coverage, customer service referrals, change providers and other common questions in the field.

The MDwise outreach team adjusted its efforts related to HIP – due to the State of Indiana opening the HIP program. Due to the Marketplace outreach in communities throughout Indiana, there has been an increased focus on HIP-related questions in the field due to individuals who attend Marketplace events, and find out if they may be eligible for HIP. In addition, MDwise outreach provides answers and resources to HIP members who have many questions about maintaining HIP coverage or transitioning to the Marketplace. The outreach team is answering eligibility questions, discussing program benefits and directing members where to enroll and how to stay enrolled on the HIP Program. For example, in Q2, 295 HIP applications were distributed at community events.

In Q2 2014, MDwise outreach and marketing organized and participated in the following activities and events where HIP information was discussed, explained and distributed in communities of all sizes throughout Indiana.

Enrollment Awareness

- MDwise Outreach distributed 297 HIP applications at community events and presentations.
- Worked with Covering Kids and Families (CKF), enrollment partners and local DFR offices to promote and conduct enrollment for the HIP health plan.
- 450 HIP applications were completed by Covering Kids & Families
- 102 HIP applications were completed at events by DFR and community enrollment centers.
- 118 CKF and enrollment partner referrals
- Partnered with enrollment partners on 321 community events to provide enrollment and promote MDwise Programs.

HIP Outreach Education and Awareness

• Completed over 143 MDwise Health Benefits Connection events in Q2. The events target HIP members and community members seeking services at local DFR offices, Provider offices, Health Departments, FQHC's, Food Pantries, Churches, free & reduced lunch programs, and other agencies and programs. There was a marked increase in questions about HIP eligibility. For example, many

- individuals were placed on the HIP waiting list and learned at the events, they could now re-apply for HIP.
- Outreach provided direct HIP education to parents at the 37 Everyone Needs Check-up Days (ENC).
 19 HIP applications were distributed and 11 referrals to CKF.
- The outreach team partnered with enrollment partners at events and community presentations to educate and provide enrollment assistance on the HIP Program.
- Provided one-on-one member education on the myMDwise Portal to 474 MDwise members and how to redeem Rewards points for completing preventive care at all events and presentations.
- Provided direct education to 3,574 members and community members on the MDwise Rewards Program
- Worked with two School Based Health Centers (SBHC) in East Chicago and Michigan City to promote HIP to uninsured parents.
- Health Risk Assessment screenings completed for new HIP members.
- Promoted Hoosier Healthwise and HIP as a solution for health insurance for the entire family. The ENC days provided an excellent opportunity to educate the entire family on affordable health insurance coverage.
- Promoted that HIP members should see their doctor within the first 90 days of becoming a MDwise HIP member.
- HIP promotion and education published in MDwise member newsletter.
- Expanded outreach initiatives to local food pantries, schools, locations, schools, GED locations,
 WorkOne, public libraries and Legal Aid sites to educate communities about where to apply for HIP,
 how to stay enrolled and to confirm HIP membership through the web interchange

Education Materials and Special Programs

- Distributed education pieces on "How to Stay Enrolled on Hoosier Healthwise & HIP", "How to Stay on MDwise", and "Where to Enroll for Hoosier Healthwise & HIP" at 307 community events and presentations.
- Educated agencies, schools and other programs about HIP at the 11 completed professional presentations.
- Distributed the "Got Insurance Brochure" to increase education on where to apply for HIP (Marion County).
- Educated HIP members on the "Your Doctor First" brochure on ER utilization.
- Promotion of INcontrol Disease Management Program for HIP members.
- Distribution of HIP Health Plan materials created by FSSA.

Presentations

 Provided education on HIP at 12 IMPACT community presentations in the southeast and west central regions. Provided updates to community members and community agencies on HIP changes – mainly the removal of the waiting list for non-custodial adults and the removal of the six-month wait.

Redetermination

- Redetermination calls and mailings made to HIP members who are in their redetermination period.
- MDwise customer service department used dialer resources to further assist with reaching members and making this process more efficient.

Providers

- Provided provider workshops for all HIP doctors.
- Provided member list to HIP providers that have HIP members that have not yet received preventive care exam.
- Distributed flyer that provided details about performance dollars MDwise will pay to the providers

- who performed well on Adult Preventative Care measure.
- Provided individual education to providers during visits or presentations.
- MDwise was involved in multiple organizations and associations focused on providers.
- MDwise outreach presented on the MDwise HIP Program to targeted high member provider offices in the NW and EC regions.
- Incorporated HIP education and resources at the MDwise Community Advisory Councils (CAC) in the north, north central, northwest and southeast regions in Q2. HIP was an agenda topic at all the CAC meetings.

HIP Power Account

- Mailed HIP new member letters with ID Cards. Letter explained the importance of receiving preventive care. The letter also explained how receiving preventive care qualifies the member for the rollover of any remaining funds in their POWER Account.
- Mailed monthly HIP POWER Account Invoice to all members reminding them of their monthly contribution.
- Mailed monthly HIP POWER Account Statement to members. The letter describes health care services
 used in the current year. Refers members to view member handbook to view preventative service
 targets.
- Mailed HIP and Hoosier Healthwise member handbook to members when they became members.
- E-mailed HIP members about how to rollover POWER account funds.

MDwise Rewards

- Promoted MDwiseREWARDS program, which is an incentive program for MDwise Hoosier
 Healthwise and Healthy Indiana Plan. The program uses incentives to encourage members to seek their
 annual check-ups and health screenings. Members earn points for healthy activities and visiting the
 doctor. The points can be redeemed for gift cards.
- Included MDwiseREWARDS information into main MDwise all program brochure, member handbook, MDwise website, and other member materials.
- MDwiseREWARDS information sheet on what activities earn points and how many points are earned
 for the activity completed available on MDwise.org or outreach can print for events and customer
 service can mail by request when members call in.
- Distributed a business card size promotion card for MDwiseREWARDS at outreach events and through provider's offices.
- Assisted members with redeeming MDwiseRewards gift cards, which included signing them up for myMDwise.
- In Q2 2014, a total of 271 HIP members redeemed their Rewards points for a gift card. This is 9% of the total number of HHW and HIP members that redeemed. The percentage of HIP members that are redeeming is reduced from the same period last year (12%) and consistent with Q4 of 2013 (13%). Members continue to have a preference for Subway gift cards for those that redeem at the \$10 level, and the Wal-Mart card is the most popular at the \$30 and \$50 levels.

MHS

In the Second Quarter CY 2014, MHS conducted and participated in many outreach activities related to general health issues education, and education about the State of Indiana programs, as well as events aimed at educating MHS members about their program operations and benefits. Below is an outline of Healthy Indiana Plan relevant activities which MHS organized, sponsored or in which MHS played a part:

April 2014

On 4/1 - 4/2/14, MHS participated in the Ivy Tech <u>Health Fair</u> in Marion County, Indiana in order to support this important community resource organization through sponsorship and to educate other participants and attendees about what MHS is, and the services MHS makes available to its members. Identify all significant program developments/issues/problems that have occurred in the current quarter, including, but not limited to, approval and contracting with new plans, benefit changes, and legislative activity.

Indiana Medicaid began to put in place the foundation for a new RBMC program for the Aged, Blind, and Disabled. Over 18,000 members were transitioned from Hoosier Healthwise and HIP to Indiana Medicaid's Fee For Service and Care Select to begin the process of the new program. During this transition Care Programs Operations had to ensure continuity of care for all 18,000 plus members, determine which members received

which notice, and ensure all records and prior authorization history arrived with their new program's contractor. We worked with the MCEs to aid in education and guidance when the members received their notices as well as ensured continuity of care.

The HIP ESP program was officially terminated on 04/30/2014. In the 4th quarter of 2013 we worked to ensure continuity of care for those members below 105% FPL, who were transitioned to coverage under one of the three HIP MCEs. In the 1st quarter of 2014 those above 105% FPL were sent to the market place. In the 2nd quarter of 2014 our focus was following through the termination procedures for an IHCP program and the contract for the vendor that facilitated HIP ESP. We successfully contracted with the company Anthem the operations of claims run out for the HIP ESP program.

Through member and provider queries we discovered an issue with the transition of pregnant women on HIP that suffered miscarriages during the transition to Hoosier Healthwise. The issue occurred regarding which program the woman was pregnant for and which was to pay claims. Each case that was handled by our team, the claims are paid the member's MCE and the provider received education regarding the appropriate billing for services related to miscarriage experienced by a HIP member.

To achieve control objectives of accurate, timely and complete reporting in compliance with the Special Terms and Conditions FSSA activities include:

- Federal Funding Director/OMPP Controller is the final approver on all budget neutrality submissions.

The State has maintained an individualized quality review team and contract compliance team. Individual teams result in a more in depth analysis of contract compliance; plan reporting, quality and accessibility of health care services, utilization of services, and progress of stated plan goals. The two teams work jointly in preparation of the monthly onsite visits. While each team brings a different perspective to the onsite visits, there are joint analysis of the plans' policies and procedures to ensure contract compliance and delivery of quality care to the members. This method results in a strong alignment of healthcare quality more closely with contract compliance.

During the second quarter the contract compliance team has focused on provider grievances and appeals, HIPAA compliance, HIP ER co-pays, HIP pregnancy transition and miscarriages covered by HIP, Third Party Liability, Cost Avoidance, Coordination of benefits, debarred individuals and provider license suspensions, and member information and education on our monthly onsite visits. We have found the MCEs to be substantially compliant; however, in depth discussion of onsite topics with the MCEs have led to improved services for HIP members. For example, the MCEs improved provider education of a pregnant HIP member transitioning from HIP to Hoosier Healthwise, including how to properly bill the MCE for miscarriage services during the transition period.

Demonstration Evaluation

Discuss progress of evaluation design and planning.

Quality topics discussed during the second quarter on site meetings were based on recommendations documented in the 2012 External Quality Review of the MCEs completed by Burns and Associates. The April on site focused on the provision of transportation services for members and the MCE's relationship with the vendors including policies and procedures. The MCEs also provided information to Quality regarding the hiring, training, and required activities of their provider representative staff. The MCEs provided an update of their Quality Management Improvement and Work Plans (QMIP) including progress made and continued challenges. The MCEs also discussed a sample of their Quality Improvement Plans (QIP) and how those relate to their current QMIP. The June on sites focused on the MCEs current quality successes and challenges relating to emergency room bounce back and inpatient readmission rates, and the current status of their Right Choices Program (RCP).

Of the 5,382 HIP members eligible for rollover in the second quarter of 2014, 59% completed a preventive service and 47% of the members received rollover of their POWER Account funds. Fifty-three percent of the members with a balance did not receive rollover due to lack of obtaining a preventive service. This creates an opportunity for the MCEs to increase member outreach efforts and educate members on incentive for preventive service. The majority of HIP members (64%) had no balance that indicates utilization of member services to meet health care needs.

Discuss initiatives to decrease ER utilization.

The FSSA monitors the emergency room utilization reports and incentivizes the MCEs to develop goals and objectives to reduce unnecessary emergency room use through the contracted payment for outcome measures. The MCEs report to the FSSA on a quarterly basis ER Bounce Back, Type of Emergency Room Utilization, and Frequency of Emergency Room Utilization. The ER Bounce Back report summarizes the rate of members who return to the emergency room within 30 days of a prior ER visit. The Frequency of Emergency Room Utilization report and the Type of Emergency Room Utilization report looks at various cohorts and summarizes the utilization of emergency room services and identifies opportunities for participation in case or care management. The MCEs also include reduction of emergency room utilization on the annual QMIP.
