- 14,491 total MAGI individuals up for renewal within the 6,774 cases
 - o 12,261 (85%) were renewed
 - o 1,753 (12%) were closed
 - 204 (12% of closures; 2% of all MAGI individuals) failed to redetermine eligibility
 - 647 (37% of closures; 5% of all MAGI individuals) failed to verify information
 - 220 (13% of closures; 1% of all MAGI individuals) were determined ineligible due to income
 - 682 (39% of closures; 5% of all MAGI individuals) failed for other reasons

July

 - 798 (37% of closures; 5% of all MAGI individuals) failed to verify information
 - 288 (13% of closures; 2% of all MAGI individuals) were determined ineligible due to income
 - 781 (36% of closures; 5% of all MAGI individuals) failed for other reasons

August

- Total MAGI cases up for renewal = 8,012 cases
- MAGI cases renewed ex parte = 1,356
- 1,356/8,012 = 17% ex parte MAGI renewals in August

August Grounds for Renewal/Failure to Renew for a portion of MAGI cases:

- 16,368 total MAGI individuals up for renewal within the 8,012 cases
 - o 13,725 (84%) were renewed
 - o 2,273 (14%) were closed
 - 340 (15% of closures; 2% of all MAGI individuals) failed to redetermine eligibility
 - 844 (37% of closures; 5% of all MAGI individuals) failed to verify information
 - 291 (13% of closures; 2% of all MAGI individuals) were determined ineligible due to income
 - 798 (35% of closures; 5% of all MAGI individuals) failed for other reasons

September

- Total MAGI cases up for renewal = 8,405 cases
- MAGI cases renewed ex parte = 1,259
- 1,259/8,405 = 15% ex parte MAGI renewals in January

September Grounds for Renewal/Failure to Renew for a portion of MAGI cases:

- 17,233 total MAGI individuals up for renewal within the 8,405 cases
 - o 14,642 (85%) were renewed
 - 2,250 (13%) were closed
 - 360 (16% of closures; 2% of all MAGI individuals) failed to redetermine eligibility
 - 772 (34% of closures; 4% of all MAGI individuals) failed to verify information
 - 284 (13% of closures; 2% of all MAGI individuals) were determined ineligible due to income
 - 834 (37% of closures; 5% of all MAGI individuals) failed for other reasons

October

- Total MAGI cases up for renewal = 8,134 cases
- MAGI cases renewed ex parte = 1,160
- 1,160/8,134 = 14% ex parte MAGI renewals in October

We do not yet have the detailed information about grounds for cases that closed in October, 2015.
