Dear Mr. Douglas:

Enclosed is an approved copy of California State Plan Amendment (SPA) Number 10-018, which establishes the State's tribal consultation policy. This SPA implements Section 5006(e) of the Recovery Act, which mandates that States consult with Tribes and designees of Indian health programs on State plan amendments, waiver requests, or proposals for a demonstration project that are likely to have a direct effect on Indians, Indian health programs, or urban Indian organizations. The SPA is effective October 1, 2010.

As the State continues to work with the Tribes, Indian Health programs and Urban Indian organizations to strengthen the relationships, we recommend that the State work with the Tribes, Indian Health programs and Urban Indian organizations to clarify the process for initiating the consultation process when issues and/or concerns are raised. We also recommend that the State work with the Tribes, Indian Health programs and Urban Indian organizations to clarify the process for working through conflicts as they are raised through the consultation process.
