School-Based Individualized Education Plan (IEP) Specialized Transportation Services

Specialized transportation includes transportation of a child to/from an appropriate provider site to receive medically appropriate and necessary IEP/IFSP services, including transportation to/from a participating school district.

Specialized transportation costs include those for adapted vehicles defined as: "a vehicle with wheelchair lifts, other special modifications or appropriate adaptations which are necessary to equip a vehicle to transport children with disabilities."

Specialized transportation services will be provided in compliance with federal requirements and will be paid when an eligible participant's need for special transportation is specified in the IEP/IFSP as a required service. The child must require specialized transportation in an adapted vehicle based on the needs of an individual with a disability. A medical service must be provided on the day that specialized transportation is billed. School districts will bill Medicaid for a one-way trip on a mileage basis, and will subsequently complete an annual cost report detailing allowable transportation costs.

Specialized transportation is covered only when it is necessary to receive another Medicaid service, and the need for both the Medicaid service and the specialized transportation are specified in the IEP/IFSP. Similar transportation would be required if the child was not in a school setting.

School-Based Individualized Education Plan (IEP) Specialized Transportation Services Payment Methodology

Effective dates of service on or after July 1, 2020, providers will be paid on a cost basis. Providers will be reimbursed based on interim rates for school-based IEP direct services (hereafter referred to as direct services) and specialized transportation services at the lesser of the providers billed charges or the interim rate. This reimbursement as part of a cost-based methodology will include an annual cost report and reconciled settlement. On an annual basis, a cost reconciliation and cost settlement will be processed for all over and under payments. Specialized transportation may be claimed as a Medicaid service by meeting the following conditions:

- 1) Specialized transportation is listed explicitly in the IEP/IFSP as a required service;
- 2) An eligible direct medical service, listed in the IEP/IFSP, is provided on the day that specialized transportation is provided; and
- 3) The service billed only represents the costs associated with one-way trips in specially adapted vehicles for direct medical services as listed in the IEP/IFSP.

Specialized transportation costs included on the cost report will only include those personnel and non-personnel costs associated with transportation to or from an IEP/IFSP Medicaid service. The expenditures identified in the cost report include the following:

- 1) Drivers;
- 2) Aides/Monitors;
- 3) Mechanics;
- 4) Substitute Drivers;
- 5) Fuel;
- 6) Repairs and Maintenance;
- 7) Rentals;
- 8) Contracted Use Cost;
- 9) Insurance; and
- 10)Vehicle Depreciation

The source of these costs will be audited Chart of Accounts data kept at the school district level and by the appropriate contractor determined by the Missouri Department of Social Services (DSS). The Chart of Accounts is uniform throughout the state of Missouri. Costs will be reported on a cash or accrual basis, depending on the school district.

Specialized transportation costs include those for wheelchair lifts and other special modifications or appropriate adaptations which are necessary to equip a vehicle to transport children with disabilities.

A- Methodology for specialized transportation: For school districts that are not able to discretely identify the specialized transportation cost from the general education transportation costs, a specialized transportation cost discounting methodology will be applied. A rate will be established and applied to the total transportation cost of the school district. This rate will be based on a ratio of total IEP students receiving specialized transportation. The result of this rate (% of total students that are IEP/IFSP students receiving specialized transportation) will be multiplied by the school district's General Transportation Costs and will be included on the cost report.

B. Methodology for specialized transportation: For school districts that are able to identify the specialized transportation costs, the school district will include those costs as indicated on page 52, of Attachment 4.19B of the state plan.

Costs for both A. and B. above will be discounted in the cost report using the Medicaid One Way Trip Ratio - A school district-specific Medicaid One Way Trip Ratio will be established for each participating school district. When applied, this Medicaid One Way Trip ratio will discount the transportation costs by the percentage of Medicaid IEP one way trips. This ratio ensures that only Medicaid allowable transportation costs are included in the cost reconciliation. The Medicaid One Way Trip Ratio will be calculated based on the ratio of Medicaid Enrolled IEP/IFSP One Way Trips divided by the total number of IEP/IFSP One Way Trips.
