Please Note: When the targeted case manager and the provider's counselor for the client participate in cross agency/program team treatment planning, TCM services are billable service.

II. Targeted case management services provided by a targeted case manager skilled in service delivery to those with substance use disorders with possible co-occurring mental illness based on a fee for service and is included as a billable service under TCM for Substance Use Disorders.

All rates are published on the agency's website www.mtmedicaid.org. Except as otherwise noted in the plan, State developed fee schedule rates are the same for both governmental and private providers.
