Medical Support and Payments: Individuals can attest on their application that they agree to cooperate with the state in establishing paternity and obtaining medical support payments. If information is received (post-authorization) that the individual is not cooperating, the agency would take action to terminate the parent's eligibility, however good cause would be researched prior to taking an adverse action. Currently in Pennsylvania, the non-cooperation of a parent does not impact a child's Medicaid eligibility.
