Of the 42 states that included performance rates in their EQR technical reports, 34 states included comparisons to previous years' rates and 32 states included comparisons to HEDIS rates. Comparisons to previous years' rates allow states to monitor MCP performance over time, while comparisons to national HEDIS rates allow states to benchmark their performance relative to other state Medicaid programs.
