

Updates to the Child and Adult Core Health Care Quality Measurement Sets

This document provides a list of links to all updates to the Center for Medicaid and CHIP Services (CMCS) Core Set of children's health care quality measures for Medicaid and the Children's Health Insurance Program (CHIP) (the Child Core Set) and the Core Set of health care quality measures for adults enrolled in Medicaid (the Adult Core Set).

A Tool to Advance Health Quality, Equity, and Access

The Core Sets are a foundational tool for understanding the quality of healthcare provided in Medicaid and CHIP. The Core Sets help CMS and states assess the access to and quality of health care being provided to Medicaid and CHIP beneficiaries and identify and improve understanding of the health disparities experienced by Medicaid and CHIP beneficiaries. CMS encourages states to use Core Set data to identify disparities in care and to develop targeted quality improvement efforts to advance health equity.

Annual Requirement to Update Core Sets

Part of implementing an effective quality measures reporting program is to periodically reassess the measures. Many factors, such as changes in clinical guidelines, experiences with reporting, and performance rates, may warrant modifying the measure set.^{1, 2} Section 1139A of the Social Security Act (the Act), provides that, beginning annually in January 2013, the Secretary shall publish recommended changes to the Child Core Set measures.³ Section 1139B of the Act, provides that the Secretary shall issue updates to the Adult Core Set beginning in January 2014 and annually thereafter.⁴

Child Core Set
