# New Child Core Set Measure: Metabolic Monitoring for Children and Adolescents on Antipsychotics (APM-CH)

Description	Percentage of children ages 1 to 17 who had two or more antipsychotic prescriptions and had the following forms of metabolic testing:  • Blood glucose testing  • Cholesterol testing  • Both blood glucose and cholesterol testing			
Measure Steward	National Committee for Quality Assurance (NCQA)			
Data Source	Administrative			
Denominator	Beneficiaries ages 1 to 17 with at least two antipsychotic medication dispensing events of the same or different medications on different dates of service.			
Numerators	<ul> <li>Beneficiaries who received at least one test for blood glucose during the measurement year.</li> <li>Beneficiaries who received at least one test for LDL-C or cholested during the measurement year.</li> <li>Beneficiaries who received at least one test for blood glucose ANI least one test for LDL-C or cholesterol during the measurement year.</li> </ul>			



# New Adult and Health Home Core Set Measure: Use of Pharmacotherapy for Opioid Use Disorder (OUD-AD/HH)

Description	Percentage of Medicaid beneficiaries ages 18 to 64 with an opioid use disorder (OUD) who filled a prescription for or were administered or dispensed an FDA-approved medication for the disorder during the measurement year. Five rates are reported:  • A total (overall) rate capturing any medications used in medication assisted treatment of opioid dependence and addiction.  • Four separate rates representing the following types of FDA-approved drug products:  - Buprenorphine  - Oral naltrexone  - Long-acting, injectable naltrexone  - Methadone

Data Source	Administrative

# New Adult and Health Home Core Set Measure: Use of Pharmacotherapy for Opioid Use Disorder (OUD-AD/HH) (cont.)

Denominator	Beneficiaries who had at least one encounter with a diagnosis of opioid abuse, dependence, or remission (primary or other) at any time during the measurement year.			
Numerators	<ul> <li>This measure includes a total rate as well as four separate rates representing the following four types of FDA-approved drugs:</li> <li>Total: Beneficiaries who had evidence of at least one prescription filled, or were administered or dispensed an FDA-approved medication for OUD during the measurement year.</li> <li>Buprenorphine: Beneficiaries with at least one prescription for buprenorphine at any point during the measurement year.</li> <li>Oral naltrexone: Beneficiaries with at least one prescription for oral naltrexone at any point during the measurement year.</li> <li>Long-acting, injectable naltrexone: Beneficiaries with at least one prescription for long-acting, injectable naltrexone at any point during the measurement year.</li> <li>Methadone: Beneficiaries with at least one dose of methadone at any point during the measurement year.</li> </ul>

### New Adult Core Set Measure: National Core Indicators (NCIDDS-AD)

Description	The National Core Indicators® (NCI®) provide information on beneficiaries' experience and self-reported outcomes of long-term services and supports for individuals with intellectual and developmental disabilities (ID/DD) and their families. NCI includes an in-person survey, family surveys for parents and guardians of adults and children who receive ID/DD supports, and a staff stability survey. For the purpose of the Adult Core Set, only data from the NCI In-Person Survey will be reported.	
Background	47 states already participate in NCI through their developmental disabilities agencies. ### New Adult Core Set Measure: National Core Indicators (NCIDDS-AD) (cont.)

Data Source	Survey
Data Collection	Survey must be conducted by the state or a state-contracted third-party vendor according to NCI requirements and protocols. In-person data collection is required for the face-to-face portion of the NCI In-Person Survey. Surveyors must follow protocols established in NCI trainings and training materials.
Eligible Population	Beneficiaries age 18 and older with intellectual and developmental disabilities receiving at least one service from the state-administered Developmental Disabilities system in addition to case management.
Data Submission	CMS plans to use data submitted to NASDDDS/HSRI to report state-level performance results for this measure.



### New Health Home Core Set Measure: Follow-Up After Emergency Department Visit for Alcohol and Other Drug Abuse or Dependence (FUA-HH)\*

Description	Percentage of emergency department (ED) visits for Health Home enrollees age 13 and older with a principal diagnosis of alcohol or other drug (AOD) abuse or dependence who had a follow-up visit with a corresponding principal diagnosis for AOD abuse or dependence.			
Measure Steward	National Committee for Quality Assurance (NCQA)			
Data Source	Administrative			
Denominator	ED visits for Health Home enrollees age 13 and older with a principal diagnosis of AOD abuse or dependence on or between January 1 and December 1 of the measurement year.			
Numerators	<ul> <li>7-Day Follow-Up: Follow-up visit with any practitioner, with a principal diagnosis of AOD abuse or dependence within 7 days after the ED visit (8 total days).</li> <li>30-Day Follow-Up: Follow-up visit with any practitioner, with a principal diagnosis of AOD abuse or dependence within 30 days after the ED visit (31 total days).</li> </ul>			

<sup>\*</sup> The Follow-Up After Emergency Department Visit for Alcohol and Other Drug Abuse or Dependence (FUA-AD) measure for age 18 and older was added to the Adult Core Set for FFY 2017, and has been added to the Health Home Core Set for age 13 and older as FUA-HH for FFY 2020.



# Modified Child Core Set Measure: Weight Assessment and Counseling for Nutrition and Physical Activity for Children/Adolescents (WCC-CH)

Description	Percentage of children ages 3 to 17 who had an outpatient visit with a primary care practitioner (PCP) or obstetrician/gynecologist (OB/GYN) and who had evidence of the following during the measurement year:  • Body mass index (BMI) percentile documentation  • Counseling for nutrition (New Indicator)  • Counseling for physical activity (New Indicator)			
Measure Steward	National Committee for Quality Assurance (NCQA)			
Data Source	Administrative, Hybrid, or EHR			
Denominator	Beneficiaries ages 3 to 17 with an outpatient visit with a PCP or an OB/GYN during the measurement year.			
Numerators	<ul> <li>Beneficiaries with documentation of BMI percentile during the measurement year.</li> <li>Beneficiaries with documentation of counseling for nutrition during the measurement year. (New Indicator)</li> <li>Beneficiaries with documentation of counseling for physical activity during the measurement year. (New Indicator)</li> </ul>			



## FFY 2020 Measure Specification Updates



### **Cross-cutting Measure Specification Updates**

- Modified the format of medication lists and/or value sets for compatibility with digital measure formatting for the following measures:
  - AMR-CH/AD, BCS-AD, CBP-AD/HH, CCS-AD, CIS-CH, FUH-CH/AD/HH, HPC-AD, HPCMI-AD, IMA-CH, SAA-AD, SSD-AD
- Added a bullet about how to access medication lists, available to order free of charge in the NCQA Store
   (<a href="http://store.ncqa.org/index.php/catalog/product/view/id/3741/s/hedis-2020-ndc">http://store.ncqa.org/index.php/catalog/product/view/id/3741/s/hedis-2020-ndc</a>). Use of the medication lists applies to the following measures:
  - ADD-CH, AMM-AD, AMR-CH/AD, APM-CH, APP-CH, BCS-AD, CBP-AD/HH, CHL-CH/AD, HPC-AD, HPCMI-AD, IET-AD/HH, SAA-AD, SSD-AD.



### **Cross-cutting Measure Specification Updates (cont.)**

- Clarified that when determining continuous enrollment and allowable gaps, states should combine data across all programs, delivery systems, and managed care plans.
- Added exclusions for beneficiaries with advanced illness and modified value sets for the following measures:
  - BCS-AD, CBP-AD/HH, HPC-AD, HPCMI-AD, SAA-AD
- Added guidance for determining whether telehealth is eligible for use in reporting. Measures based on HEDIS specifications include telehealth unless otherwise specified.

# Measure-specific Updates: Cervical Cancer Screening (CCS-AD)

Numerator	<ul> <li>Women ages 21 to 64 who had cervical cancer screening in the last 3 years</li> <li>Women ages 30 to 64 who had cervical cytology / HPV co-testing in the last 5 years</li> </ul>	<ul> <li>Women ages 21 to 64 who had cervical cancer screening in the last 3 years</li> <li>Women ages 30 to 64 who had cervical high-risk HPV (hrHPV) testing in the last 5 years</li> <li>Women ages 30 to 64 who had cervical cytology/ hrHPV co-testing within the last 5 years</li> </ul>



# Measure-specific Updates: Prenatal and Postpartum Care: Timeliness of Prenatal Care (PPC-CH) and Postpartum Care (PPC-AD)

	Previous (FFY 2019)	Current (FFY 2020)	
Timing of event/diagnosis (live birth)	November 6 of the year prior to the measurement year to November 5 of the measurement year	October 8 of the year prior to the measurement year to October 7 of the measurement year	
Numerator	<ul> <li>PPC-CH: exclude prenatal care visits occurring before enrollment start date</li> <li>PPC-AD: include postpartum visits on or between 21 and 56 days after delivery</li> </ul>	<ul> <li>PPC-CH: <u>include</u> prenatal care visits occurring before enrollment start date</li> <li>PPC-AD: include postpartum visits on or between <u>7 and 84 days</u> after delivery</li> </ul>	
Continuous enrollment criteria	56 days after delivery	60 days after delivery	



# Measure-specific Updates: Screening for Depression and Follow-Up Plan (CDF-CH, CDF-AD, and CDF-HH)

#### Clarified that:

- The measure is intended to promote screening of patients never previously diagnosed with depression or bipolar disorder, so any enrollee with an "active diagnosis" for depression or bipolar disorder would be excluded from the measure.
- An active diagnosis starts prior to the start of the encounter, and may or may not have an end date.
- If recommended follow-up includes additional screening, that screening must occur at the same encounter as the initial positive screen. An additional screen alone does not count toward a valid follow-up intervention.
- Added examples of a follow-up plan that meets numerator criteria, including:
  - Additional evaluation or assessment for depression
  - Completion of a Suicide Risk Assessment
  - Referral to a practitioner or program for further evaluation for depression
  - Other interventions to treat depression, including psychotherapy and pharmacological interventions

# Measure-specific Updates: Plan All-Cause Readmissions (PCR-AD and PCR-HH)

### **Major Changes**

- Added observation stays to the definition of index hospital stays (IHS) and 30-day readmission events.
- Defined outlier beneficiaries as individuals with 4+ IHS during the measurement year (Jan 1- Dec 1).
- Removed outlier beneficiaries and their discharges from the riskadjusted measure rates.
- Added the following new data elements to capture the outlier beneficiaries that were removed:
  - Count of Beneficiaries in Medicaid Population
  - Count of Outlier Beneficiaries
  - Outlier Rate



# Measure-specific Updates: Plan All-Cause Readmissions (PCR-AD and PCR-HH) (cont.)

#### **Other Updates**

- Modified risk-adjustment weighting process to incorporate observation stay IHS weights and remove base risk weights.
- Clarified that clinical conditions and hierarchical clinical conditions not listed in the risk-adjustment tables receive a weight of zero.
- Added acute and non-acute inpatient discharges to guidance on Utilization Risk Adjustment Determination.
- Added guidance on calculating risk-adjusted readmission rates as well as new data elements.



# Measure-specific Updates: Plan All-Cause Readmissions (PCR-AD and PCR-HH) (cont.)

 States should <u>exclude</u> outlier beneficiaries from reporting of existing riskadjusted readmission rates.

### **FFY 2020 Data Quality Priorities**

- Documentation of how states calculated a state-level rate across multiple reporting units
  - If reporting units used different methodologies (for example, several MCOs used administrative data only and several used the hybrid method), note the number of reporting units using each methodology in the "Additional Notes/Comments on Measure" section.
  - Under the section "Combined Rates from Multiple Reporting Units," indicate whether the state-level rates are weighted by population size.
    - Similar guidance applies to creating a SPA-level rate for the Health Home Core Set.

### FFY 2020 Data Quality Priorities (cont.)

- Documentation of which populations and services are excluded from the measures
  - Programs (Medicaid, CHIP)
  - Delivery systems (managed care, fee-for-service, PCCM)
  - Special populations (for example, dual eligibles or individuals in foster care)
  - Health care settings (for example, services provided at federally-qualified health centers, rural health clinics, or Indian Health Service facilities)
    - If your state cannot include some measure-eligible populations, please describe the missing population and the size of the excluded population



### FFY 2020 Data Quality Priorities (cont.)

- Alignment between measures included in the Child, Adult, and Health Home Core Sets
  - Ensure that cross-cutting measures are calculated using consistent methodology
  - Ensure that cross-cutting measures are reported for all applicable Core Sets
- Documentation of any deviations from the Core Set specifications, including age groups, data sources, and methods
- Documentation of any changes in populations, denominators, or rates between reporting years
