SUD utilization of any SUD treatment and outpatient services remains at lower levels than prior to the COVID-19 public health emergency, though some metrics reflect increased utilization. The overall SUD treatment measure ("Any SUD treatment") continued to increase this quarter and appears to be partially impacted by a return of beneficiaries using residential and inpatient services.

There were significant increases in the HIT metrics due to the activities of the HIE Connectivity grant, as outlined in the implementation plan.

There was a significant increase in the number of critical incidents. The District attributes this change to natural variation.
