<b>SMI/SED-related demonstration goals and objectives</b>	<p><b>Ensuring Quality of Care in Psychiatric Hospitals and Residential Settings.</b> Hospitals that meet the definition of an IMD in which beneficiaries receiving demonstration services under the SMI and SED program are residing must be licensed or approved as meeting standards for licensing established by the agency of the state or locality responsible for licensing hospitals prior to the state claiming FFP for services provided to beneficiaries residing in a hospital that meets the definition of an IMD. <sup>a</sup> **SUD and SMI/SED demonstration components start dates:** For monitoring purposes, CMS defines the start date of the demonstration as the *effective date* listed in the state's STCs at time of SUD and SMI/SED demonstration component approvals. For example, if the state's STCs at the time of SUD demonstration approval note that the SUD demonstration is effective January 1, 2020 – December 31, 2025, the state should consider January 1, 2020 to be the start date of the SUD demonstration. Note that the effective date is considered to be the first day the state may begin its SUD or SMI/SED demonstration component. ## **2. Executive summary**

### **SUD**

During this reporting period, the state observed a decrease in the number of beneficiaries who received any SUD treatment, used outpatient services, used residential and inpatient services, and had a claim for MAT for SUD. The state also observed a decrease in the use of opioids at high dosages in persons without cancer, the concurrent use of opioids and benzodiazepines, and Emergency Department utilization.

Between CY2022 and CY2023, the state observed a decrease in the initiation of AOD treatment for alcohol use or dependence, and other drug abuse or dependence. During that same time period, the state also observed a decrease in engagement of AOD treatment for alcohol abuse or dependence, opioid abuse or dependence, other drug abuse or dependence, and total AOD abuse or dependence. The state observed a decrease in access to preventative/ambulatory care for adults with SUD.

The state observed an increase in beneficiaries who used intensive outpatient and/or partial hospitalization services for SUD, used withdrawal management services, and had continuity of pharmacotherapy for Opioid Use Disorder. Between CY2022 and CY2023, the state observed an increase in the initiation of AOD treatment for opioid use or dependence and total AOD abuse or dependence. The state observed an increase in follow-up within both 30 and 7 days after an Emergency Department visit for AOD.

### **SMI**

During this reporting period, the state observed a decrease in the use of first-line psychosocial care for children and adolescents on Antipsychotics, inpatient mental health services, and Emergency Department services. The state also observed a decrease in the count of beneficiaries in the demonstration population as well as the percentage of children and adolescents on antipsychotics who received cholesterol testing

The state observed an increase in 30-day all cause readmissions, medication continuation following inpatient psychiatric discharge, follow-up within both 30 and 7 days after hospitalization for mental illness for ages 6-17 and adult 18 and older, and follow-up within 30 and 7 days after an Emergency Department visit for mental illness. The state also observed an increase in the number of beneficiaries in the demonstration population who used intensive outpatient and/or partial hospitalization services related to mental health, outpatient services for mental health, any services for mental health, and follow-up care for adult Medicaid beneficiaries who are newly prescribed an antipsychotic medication.

In September, the state went live with the Behavioral Health Treatment and Referral Program for early adopters, including select hospitals and managed care plans

### **Evaluation**

The state's independent assessor has begun the demonstration evaluation and there are no barriers in achieving the goals and timeframes agreed to in the STCs at this time.
