Dear Director Sandoe,

Oregon submitted a draft Approved Designated State Health Programs (DSHP) List on January 31, 2023, in accordance with the special terms and condition (STCs) 8.1.e. On August 4, 2023, the Centers for Medicare & Medicaid Services (CMS) approved a subset of the programs submitted, as an attachment to the STCs for Oregon's section 1115 demonstration project entitled, "Oregon Health Plan (OHP)" (Project Nos. 11-W-00415/10; 21-W-00073/0), effective through September 30, 2027, while CMS and the state continued negotiation of the remaining proposals. CMS is approving the remaining programs from the state's draft Approved DSHP List. A copy of the approved attachment is enclosed and will be incorporated into the STCs as a revised Attachment F.

This approval is conditioned upon compliance with the previously approved STCs, which set forth in detail the nature, character, and extent of anticipated federal involvement in the project. In addition, as stipulated in the STCs, the state must continue conducting monitoring and evaluation of all DSHP-funded initiatives.
