Dear Director Sandoe,

The Centers for Medicare & Medicaid Services (CMS) is approving the climate-support payment methodology document that the state submitted January 26, 2024, in accordance with special term and condition (STC) 9.14. This document reflects the payment methodologies Oregon will use for providing climate-support devices and the associated Community Care Organization (CCO) administrative payments for operating this Health-Related Social Needs (HRSN) benefit, as authorized by Oregon's section 1115 demonstration project entitled, "Oregon Health Plan (OHP)" (Project No. 11-W-00415/10; 21-W-00073/10).

The state may claim federal financial participation (FFP) for services back to the date of payment, so long as the state conducted adequate state-level public notice consistent with 42 CFR 447.205 prior to using that methodology to pay for HRSN services. The two-year timely claims filing provisions under section 1132 of the Social Security Act and 45 CFR Part 95 continue to apply to all payments and claims under this demonstration. The state must reconcile payments to providers and federal claims to match those rates permitted by the approved payment methodology. This approval is conditioned upon compliance with the previously approved STCs, which set forth in detail the nature, character, and extent of anticipated federal involvement in the project.

- Mercer estimates that fixed plus variable HRSN climate device admin funding will allow for approximately 1.1 to 3.9 FTEs (based on Tier) to accommodate: Case Management, Outreach & Engagement, Screenings; CBO/HRSN Provider Network Management; and Member Services functions; plus a 30% to 40% load (based on Tier) in addition to FTE staffing estimates for Climate Devices Storage Fees, Payment and Claims Processing, and General Administrative Expenses & Overhead.
- Fixed PMPM will increase when HRSN Housing and Nutrition services go into effect. Mercer projects future PMPMs will represent a lower percentage of HRSN service costs than those reflected in climate device admin loads.
- Variable admin load will be updated when HRSN Housing and Nutrition services go into effect.
