Room and board costs are not considered allowable costs for residential treatment service providers unless they qualify as inpatient facilities under section 1905(a) of the Act.

Changes in Metrics 6, 8, 10 and 24 may be related to the fact that during January 2023, many unhoused people were placed in the state's "warming" shelter, and care coordination services to help these individuals access treatment began in February 2023.

Increases in Metric 9 may be related to a new provider beginning operations and providing more PHP and IOP for stimulant use disorders that don't meet the ASAM criteria for residential treatment.

The change in Metric 12 is likely due to normal fluctuation over time.

For Metric 23, the state notes that many factors influence overdose rates. These include drug seizures, influx of counterfeit pills, new analogues, or additives (e.g., Zylazine).

For Metric 11, Rhode Island is not aware of any specific factors that led to this change.
