We have reviewed the proposed amendment to add section 7.4.A., Rescissions to the State's Disaster Relief Policies for the COVID-19 National Emergency, to the Arkansas Medicaid state plan as submitted under transmittal number (TN) AR-22-9912. This amendment proposes to rescind temporary policies in section 7.4., Medicaid Disaster Relief for the National Emergency.

We conducted our review of your submittal according to the statutory requirements at section 1902(a) of the Social Security Act and implementing regulations. Section 7.4 of the Medicaid state plan provides temporary authority for these provisions and is intended to be in effect only for the duration of the COVID-19 public health emergency. Due to the temporary nature of this provision, Medicaid SPA Transmittal Number AR-22-9912 is approved effective January 7, 2023.

7.4.A. Rescissions to the Arkansas Disaster Relief Policies for the COVID-19 National Emergency Found in Disaster SPA 21-0012

Effective January 7, 2023, the agency rescinds all elections found in Section 7.4 of SPA Number 21-0012 (approved on March 16, 2022) temporarily increasing the payment COVID-19 vaccine administration for doses 1 and 2 to respond to the changing needs of the State of Arkansas considering the continued COVID-19 Public Health Emergency.

On December 7, 2022, DHS published notification of all policies that would be sunsetting on its website at https://humanservices.arkansas.gov/covid-19/dhs-response-to-covid-19/updates-for-providers/changes-to-medicaid-ending-effective-december-31-2022/. These policies remain posted and can be reviewed by all Medicaid providers and clients.
