6. Medical care and any other type of remedial care under State Law, furnished practitioners within the scope of their practice as defined by State Law.

j. Licensed School Psychologist

- A. The Program covers medically necessary psychological services rendered to participants in the school setting by licensed school psychologists in accordance with COMAR 10.09.50.
- B. Provider Qualifications:

A Licensed School Psychologist, formerly referred to as Certified School Psychologist, shall be licensed in accordance with state regulations to practice in the jurisdiction in which services are provided. Certified School Psychologist certificates will be accepted until January 1, 2028, due to a state certification transition period.

C. Preauthorization:

Providers must obtain preauthorization for all services for which a claim is to be submitted with the exception of IEP/IFSP services where the authorization for the service is contained within the IEP/IFSP.

4.B. Early and periodic screening and diagnosis of individuals under 21 years of age, and treatment of conditions found.

- 11. To participate in the Maryland Medical Assistance <u>Program as an EPSDT School</u> <u>Health-Related</u> Services or Health-Related Early Intervention Services provider, a provider shall:
  - a. At a minimum, meet the licensure and certification requirements for their profession;
  - b. Have experience with rendering services to individuals from birth to 21 years; and
  - c. For services rendered in accordance with an Individualized Education Program (IEP) or Individualized Family Service Plan (IFSP), gain annual approval by the multidisciplinary team which develops the recipient's IEP or IFSP for continued treatment.

- 5.e The Agency reimburses schools for psychiatric evaluations when required under an Individualized Education Program (IEP) or Individualized Family Service Plan (IFSP) For all dates beginning January 1, 2010, the State will reimburse for this service at the same rate that it reimburses all other non-governmental providers as described in 5.b.
- 5.f Effective January 1, 2023, the reimbursement rate for treatment in place and mobile integrated health is set at \$150 per event. Except as otherwise noted in the plan, state-developed fee schedule rates are the same for both governmental and private providers of treatment in place and mobile integrated health services. These services are provided by emergency service transporters under supervision of a physician.

#### **Treatment in Place:**

Emergency service transport providers may be reimbursed for medically necessary services rendered to an individual without subsequent transportation when:

- 1. The emergency response system (9-1-1) is activated;
- 2. An ambulance is dispatched; and
- 3. At a minimum the provider administers a patient assessment

#### Mobile Integrated Health:

Emergency service transport providers will be reimbursed for medically necessary community-based preventative, primary, chronic, preadmission, or post admission health care services provided to a participant when the services are:

- 1. Within the scope of practice of the emergency medical services provider;
- 2. Provided in a home or another community-based setting to a program recipient who does not require emergency medical transport; and
- 3. Consistent with the protocols issued by the emergency medical services board.

### 5.g. Payment limitations:

- Preoperative evaluations for anesthesia are included in the fee for administration of anesthesia and the provider may not bill them as consultants.
- Referrals from one physician to another for treatment of specific patient problems may not be billed as consultations.
- The operating surgeon may not bill for the administration of anesthesia or for an assistant surgeon who is not in his employ.
- Payment for consultations provided in a multi-specialty setting is limited by criteria established by the Department.
- The Department will not pay a provider for those laboratory or x-ray services performed by another facility but will instead pay the facility performing the procedure directly.

  - Licensed Psychologist
  - Licensed Clinical Social Worker

- 18a. The Department reimburses practitioners identified as "mental health professionals" differentially dependent on their licensure class. The professionals eligible for reimbursement are licensed under State law and include nurse psychotherapists, licensed doctoral psychologists, licensed and certified social workers, licensed and certified professional counselors, and certified nurse practitioners. Services and provider qualifications are limited to those outlined in 3.1A of the Maryland State Plan.
- 18b. Maryland bases the rates on market factors, primarily comparable rates from other insurers. For each class of mental health professional and for each CPT procedure code, rates paid by other insurers are reviewed. Since Maryland reimburses for a broader range of services than many insurers, some adjustments and interpolations are required. In order to establish rates for similar procedures, rates are adjusted based upon time and intensity of effort required for the procedure in question. Whenever possible, rates are then benchmarked against Medicare rates for similar procedure codes. On average, State rates are below allowable Medicare rates. The Department's reimbursement methodology was set on July 1st, 2008 and is effective for services provided on or after that date. Except as otherwise noted in the Plan, rates are the same for both governmental and private individual practitioners. Updated rates are included on the current fee schedule which is published on the Department's website at: health.maryland.gov/providerinfo.
- 18c. The Department reimburses schools for certain mental health services when required under an Individual Education Program (IEP) or Individual Family Service Plan (IFSP) and when provided by a licensed mental health provider. These services include: individual psychotherapy, family psychotherapy, group psychotherapy, and psychological testing. For all dates beginning January 1, 2010, the State will reimburse for this service at the same rate that it reimburses all other non-governmental mental health providers as described in 18b.
- 18d. Effective January 1, 2025, the Department reimburses schools for mental health services within the provider's scope of practice for recipients who do not have an IEP or IFSP and when provided by licensed and certified social workers ..

#### Preauthorization:

The Department may provide an exception to the first limitation rule above if it, or its agent, finds the additional service is medically necessary, not duplicative.

- 18e. Payment limitations:
  - The Department will not pay for services which do not involve direct patient contact.
  - The provider may not bill the Program or the recipient for:
    - Completion of forms and reports;
    - Broken or missed appointments;
    - Professional services rendered by mail;
    - Services which are provided at no charge to the general public with the exception of certain mental health services that are rendered in the school setting to eligible recipients ; and
    - Providing a copy of a recipient's medical record when requested by another licensed provider on behalf of a recipient.
  - The Department reimburses only for one service per service date.
  - The Department does not reimburse for outpatient health services provided to an individual when the individual is in a hospital or residential treatment center
  - The Department does not reimburse services provided by a school health-related service provider that are not included on a child's IEP or IFSP, with the exception of certain mental health services described in 18.d

#### Licensed School Psychologists

a. The Department reimburses for licensed school psychologists. Services and provider qualifications are limited to those outlined in 3.1A of the Maryland State Plan.

b. The Department reimburses schools for mental health services within the provider's scope of practice when required under an Individual Education Program (IEP) or Individual Family Service Plan (IFSP) and when provided by a licensed school psychologist. These services include: individual psychotherapy, family psychotherapy, group psychotherapy, and psychological testing. The State will reimburse for this service at the same rate that it reimburses all other non-governmental mental health providers as described in 18b.

c. Effective January 1, 2025, the Department reimburses schools for mental health services within the provider's scope of practice for recipients who do not have an IEP or IFSP and when provided by an MSDE licensed school psychologist.

d. The State will reimburse for services described in b and c at the same rate that it reimburses all other nongovernmental mental health providers as described in 18b.

e. Limitations:

- 1) The Department reimburses only for one service per service date; and
- 2) The Department does not reimburse for school-based mental health services provided to an individual when the individual is in a hospital or residential treatment center; and
- 3) The Department does not reimburse mental health services provided by a school health-related services provider that are not included on a child's IEP or IFSP for dates of service prior to January 1, 2025.

Preauthorization: The Department may provide an exception to the first limitation rule above if it, or its agent, finds the additional service is medically necessary, not duplicative.

### f. Payment limitations:

- The Department will not pay for services which do not involve direct, face-to-face patient contact.
- The provider may not bill the Program or the recipient for:
  - Completion of forms and reports;
  - Broken or missed appointments;
  - Professional services rendered by mail;
  - Services which are provided at no charge to the general public with the exception of certain mental health services that are rendered in the school setting to eligible recipients; and
  - Providing a copy of a recipient's medical record when requested by another licensed provider on behalf of a recipient.
