Dear Deputy Secretary Richard:

We have reviewed the proposed amendment to add section 7.4 Medicaid Disaster Relief for the COVID-19 National Emergency to your Medicaid state plan, as submitted under transmittal number (TN) 22-0015. This amendment proposes to implement temporary policies, which are different from those policies and procedures otherwise applied under your Medicaid state plan, during the period of the Presidential and Secretarial emergency declarations related to the COVID-19 outbreak (or any renewals thereof).

On March 13, 2020, the President of the United States issued a proclamation that the COVID-19 outbreak in the United States constitutes a national emergency by the authorities vested in him by the Constitution and the laws of the United States, including sections 201 and 301 of the National Emergencies Act (50 U.S.C. 1601 et seq.), and consistent with section 1135 of the Social Security Act (Act). On March 13, 2020, pursuant to section 1135(b) of the Act, the Secretary of the United States Department of Health and Human Services invoked his authority to waive or modify certain requirements of titles XVIII, XIX, and XXI of the Act as a result of the consequences of the COVID-19 pandemic, to the extent necessary, as determined by the Centers for Medicare & Medicaid Services (CMS), to ensure that sufficient health care items and services are available to meet the needs of individuals enrolled in the respective programs and to ensure that health care providers that furnish such items and services in good faith, but are unable to comply with one or more of such requirements as a result of the COVID-19 pandemic, may be reimbursed for such items and services and exempted from sanctions for such noncompliance, absent any determination of fraud or abuse. This authority took effect as of 6 PM Eastern Standard Time on March 15, 2020, with a retroactive effective date of March 1, 2020. The emergency period will terminate, and this state plan provision will no longer be in effect, upon termination of the public health emergency, including any extensions.

Pursuant to section 1135(b)(5) of the Act, for the period of the public health emergency, CMS is modifying the requirement at 42 C.F.R. 430.20 that the state submit SPAs related to the COVID-19 public health emergency by the final day of the quarter, to obtain a SPA effective date during the quarter, enabling SPAs submitted after the last day of the quarter to have an effective date in a previous quarter, but no earlier than the effective date of the public health emergency.

The State of North Carolina also requested a waiver of public notice requirements applicable to the SPA submission process. Pursuant to section 1135(b)(1)(C) of the Act, CMS is waiving public notice requirements applicable to the SPA submission process. Public notice for SPAs is required under 42 C.F.R. §447.205 for changes in statewide methods and standards for setting Medicaid payment rates, 42 C.F.R. §447.57 for changes to premiums and cost sharing, and 42 C.F.R. §440.386 for changes to Alternative Benefit Plans (ABPs). Pursuant to section 1135(b)(1)(C) of the Act, CMS is approving the state's request to waive these notice requirements otherwise applicable to SPA submissions.

The State of North Carolina also requested a waiver to modify the tribal consultation timeline applicable to this SPA submission process. Pursuant to section 1135(b)(5) of the Act, CMS is also allowing states to modify the timeframes associated with tribal consultation required under section 1902(a)(73) of the Act, including shortening the number of days before submission or conducting consultation after submission of the SPA.

These waivers or modifications of the requirements related to SPA submission timelines, public notice, and tribal consultation apply only with respect to SPAs that meet the following criteria: (1) the SPA provides or increases beneficiary access to items and services related to COVID-19 (such as by waiving or eliminating cost sharing, increasing payment rates or amending Alternative Benefit Plans to add services or providers); (2) the SPA does not restrict or limit payment or services or otherwise burden beneficiaries and providers; and (3) the SPA is temporary, with a specified sunset date that is not later than the last day of the declared COVID-19 public health emergency (or any extension thereof). We nonetheless encourage states to make all relevant information about the SPA available to the public so they are aware of the changes.

We conducted our review of your submittal according to the statutory requirements at section 1902(a) of the Act and implementing regulations. This letter is to inform you that North Carolina's Medicaid SPA Transmittal Number 22-0015 is approved effective July 1, 2021. This SPA is in addition to all previously approved Disaster Relief SPAs and does not supersede anything approved in those SPAs.

Enclosed is a copy of the CMS-179 summary form and the approved state plan pages.

Effective July 1, 2021, a 5% temporary Covid-19 rate increase will be implemented for all FFS Medicaid programs, including Indian Health Services and Cherokee Indian Health Association programs except for hospital inpatient and hospital outpatient services and services mentioned below through December 31, 2021.

Effective July 1, 2021 through December 31, 2022 a temporary Covid-19 rate increase of 5% and then 10% will be applied ONLY to the following FFS programs: Skilled Nursing Facilities, Veteran Home Nursing Facilities, and the Tsali Tribal Skilled Nursing Facility.

Effective July 1, 2021 a 15% temporary Covid-19 rate increase will be implemented for ICF-IID (Private Facilities) providers through January 31, 2022.

Effective July 1, 2021 a 15% temporary Covid-19 rate increase will be implemented for PRTF and ICF-IID (State Facilities) providers through June 30, 2022.

Effective July 1, 2021 a 5% temporary Covid-19 rate increase will be implemented for Inpatient (State Facilities), SA Non-Med and Medical Community Residential, and Crisis Services (except Mobile Crisis) providers through June 30, 2022.

Effective July 1, 2021 a 5% temporary Covid-19 rate increase will be implemented for Psych Rehab, Peer Support, Community Support, Outpatient SUD-SAIOP, SACOT, and Partial Hosp/Day TX, providers through February 28, 2022 using HCBS 10% FMAP American Rescue Plan Act funds.

Effective July 1, 2021 a 5% temporary Covid-19 rate increase will be implemented for Case Management, Opioid Tx, Ambulatory detox, Diagnostic Assessment, ACT, MST, IIHS providers through March 31, 2022 using HCBS 10% FMAP American Rescue Plan Act funds.

Effective July 1, 2021 a 5% temporary Covid-19 rate increase will be implemented for Mobile Crisis providers through the end of the PHE.

Effective July 1, 2021 a 5% temporary Covid-19 rate increase will be implemented for rehab service providers through February 28, 2022 using HCBS 10% FMAP American Rescue Plan Act funds.

Effective July 1, 2021 a 5% temporary Covid-19 rate increase will be implemented for PDN provider rates, and effective November 1, 2021 an additional \$1.56 flat rate increase will be implemented on top of the 5% increase using HCBS 10% FMAP American Rescue Plan Act funds. Both Increases will end on February 28,2022.

Effective July 1, 2021, a 5% and then 10% temporary Covid-19 rate increase will be implemented for Home Health Providers through June 30, 2022 using HCBS 10% FMAP American Rescue Plan Act funds

Effective July 1, 2021, a 5% and 10% temporary Covid-19 rate increase will be implemented for Personal Care Services (PCS) through December 31, 2022 using HCBS 10% FMAP American Rescue Plan Act funds. An additional Uniform COVID-19 flat rate of \$1.00 will also be added on top of the 5% and 10% temporary Covid-19 rate increases using HCBS 10% FMAP American Rescue Plan Act funds from November 1, 2021 through December 31, 2022.

Effective October 1, 2021, through December 31, 2021, a \$95 uniform COVID-19 rate will be applied to Skilled Nursing Facility rates. Effective January 1, 2022 through December 31, 2022, the Uniform COVID-19 rate will be \$47.50. Both uniform rate increases are in addition to COVID-19 temporary 5% and 10% rate increases.

Effective July 1, 2021 a 5% temporary Covid-19 rate increase will be implemented for hospice providers through December 31, 2022.
