7. Reimbursement Methodology for Family Planning Services

- (a) Payment for Family Planning services is made in accordance with the provisions contained in items 1 (Physicians and Certain Other Practitioners), 3 (Clinical Labs), 35 (Certified Family and Pediatric Nurse Practitioners), and 41 (Certified Registered Nurse Anesthetists and Advanced Nurse Practitioners) depending on the service provided and the provider type. For other agencies that are physician-directed and are approved to provide family planning services under this state plan, the upper payment limits will not be in excess of a fee schedule, as approved by the Single State Agency, for each of the professional services authorized as benefits.
- (b) All fee schedules are available through the agency's website as outlined in Attachment 4.19-B, page 1.
- (c) Except as otherwise noted in the plan, state-developed fee schedule rates are the same for both governmental and private providers of Family Planning Services. The agency's fee schedule rates were set as of April 1, 2025 and are effective for services provided on or after that date. The fee schedule was posted on the agency's website by April 15, 2025. All rates are published on https://pfd.hhs.texas.gov/rate-packets.
