On December 28, 2023, the Centers for Medicare & Medicaid Services (CMS) received Wisconsin State Plan Amendment (SPA) WI-23-0021 which proposes to expand substance use disorder (SUD) health home services to additional counties.

We approve Wisconsin State Plan Amendment (SPA) WI-23-0021 with an effective date(s) of October 01, 2023.

For payments made to health homes providers for health homes participants who newly qualify based on the health homes program's increased geographical coverage under this amendment, a medical assistance percentage (FMAP) rate of 90% applies to such payments for the period 10/1/2023 to 9/30/2025.

The FMAP rate for payments made to health homes providers will return to the state's published FMAP rate at the end of the enhanced match period. The Form CMS-64 has a designated category of service Line 45 for states to report health homes services expenditures for enrollees with SUD.

#### **Executive Summary**

Goals and Objectives Disorder (SUD) Health Home services, which are also referred to as Integrated Recovery Support Services provided by Hub sites. This is still a pilot program with limited geographic service areas. Seven additional counties and one additional Tribal Nation will be added to the coverage area. The Family Health Center (FHC) Minocqua Alcohol & Drug Recovery Center previously provided services only in Forest, Iron, Oneida, Price, and Vilas Counties and Forest County Potawatomi, Lac du Flambeau Chippewa, and Sokaogon Chippewa Tribal Nations. They have expanded their coverage area to include two new locations. The first is FHC Marshfield Alcohol & Drug Recovery Center to provide services in Clark, Jackson, Portage, and Wood Counties and area parts of Ho-Chunk Tribal Nation. The second location is FHC Ladysmith Alcohol & Drug Recovery Center to provide services in Rusk, Barron, and Polk Counties. In conclusion, the FHC Hub provider network is adding seven counties and one additional tribe. The Department is also adding a fourth Hub site following additional funding and direction from the Joint Finance Committee to use state Opioid Settlement dollars. Vin Baker Recovery (VBR), a member of Addiction Medical Solutions, will provide services initially in Milwaukee and subsequently will expand to Washington, Waukesha, and Ozaukee counties.
