SUD utilization of any SUD treatment and outpatient services remains at lower levels than prior to the COVID-19 public health emergency. The overall SUD treatment measure ("Any SUD treatment) continued to increase this quarter and appears to be partially impacted by a return of beneficiaries using residential and inpatient services.

There were significant increases in a majority of the HIT metrics due to the activities of the HIE Connectivity grant, as outlined in the implementation plan.

There were significant decreases in the number of grievances, appeals, and critical incidents. The District attributes these changes to natural variation.
