This letter is in reference to a setting submitted to the Centers for Medicare & Medicaid Services (CMS) for a heightened scrutiny review, in accordance with the federal home and community-based services (HCBS) regulations found at 42 CFR Section 441.301(c)(4)(5) and Section 441.710(a)(1)(2). North Dakota submitted an evidentiary package for Dakota East Day Program, a non-residential adult day setting that was originally on the grounds of a publicly operated intermediate care facility for individuals with intellectual or developmental disabilities (ICF/IID) to CMS for heightened scrutiny review on November 26, 2014. Based on the heightened scrutiny review and site visit completed in August 2015, a determination was made that the setting did not overcome the institutional presumption as at that time, the majority of individuals received were not integrated into the larger community. North Dakota was notified of this determination in an August 11, 2015 letter from CMS.

Since the initial determination, North Dakota informed CMS in the state's updated STP dated January 31, 2019 that as of March 2018, Dakota East Day Program was relocated off the grounds of the publicly operated ICF/IDD to a downtown location among other community businesses with expanded opportunity for community integration. CMS appreciates the effort of the state to provide a comprehensive evidentiary package regarding the settings' characteristics, and was pleased to learn that transportation and individual and group community. Based on review of the new information provided, CMS believes the Dakota East Day Program no longer requires heightened scrutiny review as it is no longer located on the grounds of or immediately adjacent to a public institution.

CMS requests that North Dakota validate that Dakota East Day meets all of the settings criteria required for compliance with the regulation, and assure that any modifications that need to be made to remediate gaps/non-compliance be completed on or before March 17, 2022. The state should include this setting in its ongoing monitoring activities to ensure it continues to meet the HCBS settings criteria.
