

2023 and 2024 Core Set of Behavioral Health Measures for Medicaid and CHIP (Behavioral Health Core Set)

To support CMS's efforts to improve behavioral health in Medicaid and CHIP, CMS identified a core set of 18 behavioral health measures for voluntary reporting by state Medicaid and CHIP agencies. This Core Set, which consists of 7 measures from the Child Core Set and 11 measures from the Adult Core Set, will be used by CMS to measure and evaluate progress toward improvement of behavioral health in Medicaid and CHIP.
