## IV. Pharmacy Services

#### A. General Information:

1. The agency reimburses only for prescription drugs provided by manufacturers that have a signed drug rebate agreement with the Department of Health and Human Services (HHS).

Prescriptions for drugs may be filled and refilled at the discretion of the prescriber. For those drugs specified by the agency, prior approval is required.

- 2. Payment for drugs purchased in bulk by a public agency is made in accordance with governmental statutes and regulations governing such purchases.
- Each Medical Assistance client is granted the freedom to choose his or her source of medications, except when the client is covered under a managed care plan that includes the drug benefit.
- 4. The agency covers prescription drugs when the federal Food and Drug Administration (FDA) has issued an Emergency Use Authorization (EAU) and:
  - The Department of Homeland Security (DHS) Secretary issues a material threat determination;
  - There is a military or potential military emergency;
  - There is a domestic or potential domestic emergency;
  - There is a public health or potential public health emergency; or
  - When medically necessary.
