This amendment uses the authority of section 1902(r)(2) of the Act to have a block income disregard between the current net income standard of 100% of FPL, and a gross income standard of 141% of FPL for the mandatory poverty-level related group of children aged 6 through 18 under section 1902(a)(10)(A)(i)(VII) of the Act.
