Enclosed is an approved copy of Florida's state plan amendment (SPA) 15-0002, which was submitted to the Centers for Medicare & Medicaid Services (CMS) on March 23, 2015. SPA 15-0002 approves the state recognition of same-sex couples as spouses if they are legally married under the laws of the state, territory or foreign jurisdiction in which the marriage was performed. The state will only make a determination regarding marital status when completing a determination of income in order to determine Medicaid eligibility. This amendment also indicates that the recognition of same-sex marriages apply when determining post-eligibility income, spousal impoverishment, asset transfers and estate recovery, as permitted by law. This SPA was approved on May 7, 2015. The effective date of the SPA is January 6, 2015.
