

APPENDIX K: Emergency Preparedness and Response and COVID-19 Addendum

Background:

This standalone appendix may be utilized by the state during emergency situations to request amendments to its approved waiver, to multiple approved waivers in the state, and/or to all approved waivers in the state. It includes actions that states can take under the existing Section 1915(c) home and community-based waiver authority in order to respond to an emergency. Other activities may require the use of various other authorities such as the Section 1115 demonstrations or the Section 1135 authorities.¹ This appendix may be applied retroactively as needed by the state. Public notice requirements normally applicable under 1915(c) do not apply to information contained in this Appendix.

COVID-19 pandemic. This Appendix K is additive to the approved Appendix K and includes the following modifications:

- Effective May 1, 2021, through November 30, 2021, temporarily increase the rates for the following services to 30% above the base rate for all providers to account for greater needs for staffing and the provider's ability to increase staff capacity to deliver direct services, given the impact the pandemic has had on provider workforce. Day services, including Day Habilitation, Prevocational Services, and Community Experience: Community Day Hab 1 (1:4); Community Day Hab 1 w/trans; Community Day Hab 2 (1:3); Community Day Hab 2/trans; Community Day Hab 3 (1:2); Community Day Hab 3 w/trans; Community Day Hab 4; Community Day Hab 4 w/trans; Day Habilitation Level 1; Day Habilitation Level 1 w/Transportation; Day Habilitation Level 2; Day Habilitation Level 2 w/Transportation; Day Habilitation Level 3; Day Habilitation Level 3 w/Transportation; Day Habilitation Level 4; Day Habilitation Level 4 w/Transportation; Community Experience 1:1; Community Experience 1:3 and 1:4; Adult Companion Services; Self-Directed Adult Companion Services; Personal Care; Self-Directed Personal Care; Respite In Home; Self-Directed Respite - In Home; Respite Out of Home; Self-Directed Respite - Out of Home; LPN Nursing per hour; Self-Directed LPN; RN Nursing per hour; Self-Directed RN; Assessment/Discovery; Individual Job Coach; Individual Job Developer; Prevocational Community Based (1:1 - 1:3); Employment Small Group 1:2-3; Employment Small Group 1:4; Personal Care on Worksite; Prevocational Facility Based Up to 1:15.
- Effective May 1, 2021, through November 30, 2021, pursuant to the requirements of the Fair Labor Standards Act, overtime rates will be paid at one and a half times the new temporary base rates for the following services: Adult Companion Services; Self-Directed Adult Companion Services; Personal Care; Self-Directed Personal Care; Respite In Home; Respite Out of Home; LPN Nursing per hour; Self-Directed LPN; RN Nursing per hour; Self-Directed RN. This will exceed the previously approved temporary overtime rates for this set of services. After November 30, 2021, the previously approved temporary overtime rates for this set of services will resume and will extend through the end date of the approved Appendix K.
- Effective May 1, 2021, through November 30, 2021, temporarily increase the cost limit for the LAH Waiver from \$50,000.00 to \$58,000.00. This is necessary to accommodate the increased rates described above.

All modifications apply to both the ID and LAH waivers.

Appendix K-2: Temporary or Emergency-Specific Amendment to Approved Waiver

Temporary or Emergency-Specific Amendment to Approved Waiver:

These are changes that, while directly related to the state's response to an emergency situation, require amendment to the approved waiver document. This will exceed the previously approved temporary overtime rates for this set of services. After November 30, 2021, the previously approved temporary overtime rates for this set of services will resume and extend through the end of the month in which the PHE terminates, not to exceed the end date of the approved Appendix K.
