

APPENDIX K: Emergency Preparedness and Response and COVID-19 Addendum

Background:

This standalone appendix may be utilized by the state during emergency situations to request amendments to its approved waiver, to multiple approved waivers in the state, and/or to all approved waivers in the state. It includes actions that states can take under the existing Section 1915(c) home and community-based waiver authority in order to respond to an emergency. Other activities may require the use of various other authorities such as the Section 1115 demonstrations or the Section 1135 authorities.ⁱ This appendix may be applied retroactively as needed by the state. Public notice requirements normally applicable under 1915(c) do not apply to information contained in this Appendix.

On March 13, 2020, as authorized under the Robert T. Stafford Disaster Relief and Emergency Assistance Act (the “Stafford Act”), President Donald J. Trump declared a state of emergency resulting from the ongoing Coronavirus Disease 2019 (COVID-19) pandemic. On January 31, 2020, pursuant to the Public Health Services Act, Secretary of Health and Human Services (HHS) Alex Azar declared a public health emergency. On March 12, 2020, Governor Steve Bullock issued an [executive order](#) declaring a state of emergency related to the continued spread of COVID-19 to allow the governor to direct a coordinated response to the outbreak of communicable disease. This includes mobilizing all available state resources, such as emergency funds or personnel from the National Guard. It also allows the governor to take additional steps to ease regulatory requirements, continue federal and multi-state coordination, and ensure continued access to critical services for the State’s most vulnerable.

The novel COVID-19 pandemic has already begun to place unprecedented burdens on Montana’s health care programs and systems. Per the [Centers for Disease Control and Prevention \(CDC\)](#), as of March 31, 2020, there are 177 reported COVID-19 cases; this number is expected to grow as more people become tested and the virus spreads to other communities in Montana, increasing the risk of exposure for the State’s residents. Montana has three approved 1915(c) waivers with 5400 participants, many of which are among the most vulnerable and susceptible to COVID-19. Health care workers caring for patients with COVID-19, individuals who have had close contact with persons with COVID-19, and travelers returning from affected international locations where community spread is occurring are all at elevated risk of exposure. Montana’s knowledge of COVID-19 is still rapidly evolving.

Montana has received approval to waive certain Medicaid and the Children's Health Insurance Program (CHIP) requirements to ensure sufficient health care items and services are available to meet the needs of individuals under 1135 of the Social Security Act. A number of requirements Montana has committed to in its Medicaid state plan and waiver applications are dependent on staff and provider ability to perform tasks. Due to the evolving nature of this crisis, we may reach a point where we must adjust service delivery methods, suspend home visits, and shift workload priorities due to staff shortages to in order to meet immediate health and safety needs.

This appendix K is additive to the previously approved appendix K and adds supplemental payments effective April 1, 2021. Acknowledging these are time-limited payments which are not anticipated to extend beyond March 2024, the State understands that its ability to make payments under the Appendix K authority will end following the conclusion of the Federal Public Health Emergency. The State will be responsible to seek other authority, such as amending the 1915(c) HCBS waivers, for the continuation of these payments beyond the termination date of the Appendix K for all three of Montana’s Home and Community Service waivers:

- Montana Big Sky Home and Community Based Waiver
- Montana Home and Community Based Waiver for Individuals with Developmental Disabilities
- Montana Behavioral Health Severe Disabling Mental Illness Home and Community Based Services

Stakeholder meetings with and communications from Montana Medicaid HCBS providers have identified financial instability as a major risk factor to a) ensuring ongoing service delivery and b) ability to recruit and retain workforce. DPHHS will issue supplemental payments to ARP defined Home and Community Based Providers for 24 months, using the schedule below. Supplemental payments will be issued for services that contains direct care activities. Direct care activities are those that include a direct care/personal assistance component. Direct care services can be delivered in person or virtual (if allowed by the waiver or a previous Appendix K). Providers receiving the supplemental payments will be expected to sustain and/or increase service delivery and invest in workforce recruitment and retention.

A quarterly supplemental payment of 15% of Medicaid allowable paid claims *for dates of service* between 04/1/2021 and 09/30/2021 *and billed by 10/31/2021* will be issued to HCBS waiver providers. These supplemental payments are to support providers with the increased cost hazard/retention pay, higher staffing levels and personal protective equipment and other supplies. Montana will implement these temporary changes to maintain a stable workforce and preserve significantly impacted home and community-based service behavioral health provider networks.

A quarterly supplemental payment of 12% of Medicaid allowable paid claims *for dates of service* between 10/01/2021 and 12/31/2021 *and billed by 01/31/2022* - will be issued to HCBS waiver providers. These supplemental payments are to support providers with the increased cost hazard/retention pay, higher staffing levels and personal protective equipment and other supplies. Montana will implement these temporary changes to maintain a stable workforce and preserve significantly impacted home and community-based service behavioral health provider networks.

A quarterly supplemental payment of up to 12% of Medicaid allowable paid claims *for dates of service* between 01/01/2022 and 03/31/2022 *and billed by 04/30/2022* will be issued to HCBS waiver providers. These supplemental payments will be made to providers who commit to sustaining and or increasing service delivery an investing in workforce recruitment and retention. Providers receiving the supplemental payments will be asked to demonstrate that the cost of delivering services during the applicable timeframe exceeds standard Medicaid payment rates.

A quarterly supplemental payment of up to 8% of Medicaid allowable paid claims *for dates of service* between 04/01/2022 and 09/30/2022 *and billed by 10/31/2022* will be issued to HCBS waiver providers. These supplemental payments will be made to providers who commit to sustaining and or increasing service delivery an investing in workforce recruitment and retention. Providers receiving the supplemental payments will be asked to demonstrate that the cost of delivering services during the applicable timeframe exceeds standard Medicaid payment rates. Should this time frame exceed the termination date of the Appendix K, the state will take action to continue payment through an amendment to the base waivers should the state choose to do so,

A quarterly supplemental payment of up to 4% of Medicaid allowable paid claims *for dates of service* between 10/01/2022 and 03/31/2023 *and billed by 04/31/2023* will be issued to HCBS waiver providers. These supplemental payments will be made to providers who commit to sustaining and or increasing service delivery an investing in workforce recruitment and retention. Providers receiving the supplemental payments will be asked to demonstrate that the cost of delivering services c during the applicable timeframe exceeds standard Medicaid payment rates.
