The first date range should be used to populate the Start Date and End Date fields, while the second date range defines these prior review periods and should not be included in the Start Date and End Date fields. For example, the IET-HH measure instructs states to identify enrollees with index episode start dates (IESD) that started January 1, 2021 through November 14, 2021 (the first date range).
