

## Medicaid Health Homes: SPA Overview

The Medicaid health home option available to states in 2011. Since that time, states have made significant strides in using this model to improve care coordination and care management for Medicaid beneficiaries with complex needs. As of March 2022, 19 states and the District of Columbia have a total of 34 approved Medicaid health home models.<sup>1</sup> Details of the states participating in the Medicaid health home opportunity are listed below. Some states have multiple State Plan Amendments (SPAs) to target different populations or phase-in regional implementation.
